ABOUT THE PORTFOLIO

Our environmental investments are grounded in the belief that a flourishing and equitable Oregon depends on healthy ecosystems and clean water and air for all. Through the Healthy Environment Portfolio, we work toward this in two ways: a statewide program that aims to build an inclusive environmental movement and engages and supports nonprofits working on a range of place-based and statewide efforts to protect and improve the environment; and the Willamette River Initiative, a 10-year commitment by Meyer to improve the health of the watershed that more than two-thirds of Oregonians call home.

Statewide Program

The Statewide Program works to protect and improve the health and resiliency of Oregon's environment while addressing the systems and structures in our communities that create unfair advantages for some groups and disadvantages for others in their access to a healthy environment. We prioritize efforts that aim to change systems and alter the status quo, and we value approaches that integrate community well-being, economic vitality and stewardship of our natural systems. Willamette River Initiative

The Willamette River Initiative works to improve river health along the 187-mile Willamette and its tributaries through a 10-year commitment to a healthier river system that is able to adapt to changing conditions and long-term impacts. We aim to foster a common vision and set of priorities among agencies, nonprofits and other key stakeholders working to improve the health of the Willamette River system, and build a strong foundation for long-term protection and restoration efforts. Equity Lens

Equity is a central tenet in all of Meyer’s grantmaking. All applicants — regardless of where they may be today — must demonstrate a commitment to ongoing growth through the integration of diversity, equity and inclusion (DEI) principles into both their external programming or services and internal structures and operations.

FUNDING GOALS

All proposals must advance one of the following Healthy Environment Statewide Program funding goals:

- Achieve the mutual goals of community well-being, economic vitality and environmental stewardship.
- Ensure that environmental impacts and benefits are equitably distributed among communities.
- Support a movement for a healthy environment that is effective and relevant for all of Oregon’s diverse communities.
- Ensure that natural systems are healthy and able to adapt to changing conditions and long-term impacts.

Meyer has identified several intended outcomes under each of these goals. Applicants will be asked to indicate which goal (only one) and which of its associated outcomes (up to two) that their proposed work best supports. Applications that do not make a strong and clear connection to at least one of Meyer’s intended outcomes will not be successful.

AVAILABLE FUNDING

We anticipate awarding approximately \$3.3 million for this 2017 funding opportunity for projects, programs, capacity-building efforts and operating support that will advance our Healthy Environment Statewide Program funding goals and outcomes.

We strive to fund a mix of statewide, regional-scale and local/place-based efforts in urban and rural Oregon, including Tribal nations. We encourage organizations whose work advances our Healthy Environment goals but who may not identify as environmental organizations to apply, as well as those who do identify in this way. We prioritize projects that primarily benefit communities and populations that experience disparities, including people of color, low-income populations, immigrants and refugees and indigenous communities and Tribes.

We anticipate funding projects that address a range of issues such as climate and energy, fresh water and watersheds, environmental health, pollution/toxics reduction, environmental justice, community livability and the built environment (including transportation), forest and land conservation, sustainable food systems, marine conservation, sustainable economic development and biodiversity protection.

In 2017, our Healthy Environment Statewide Program will partner with our Willamette River Initiative to fund a number of proposals under Goals 2 and 3 that specifically aim to advance diversity, equity and inclusion in the Willamette River or its tributaries. The statewide program will also continue to consider a broad range of diversity, equity and inclusion proposals from across Oregon that advance our Funding Goals 2 and 3.

WHAT DOESN'T FIT

The following are not a strong fit for the annual funding opportunity:

- Environmental education, outdoor learning and outdoor recreation projects and programs, unless they are part of a larger effort that demonstrates measureable environmental impact or systems change.*
- Projects that support public health impact or food access benefits, but do not demonstrate measurable environmental impact.*

- School or community garden programs unless they are linked to a larger-scale sustainability or environmental systems change strategy.
- Single-site/small-scale restoration, stewardship and acquisition projects unless they are part of a landscape-scale/systems change strategy.

* In support of our Willamette River Initiative, environmental education and public health projects related to the Willamette River or its tributaries are eligible for consideration under Funding Goals 2 and 3. We anticipate funding for these purposes will be limited. Please discuss your project with Willamette River Initiative staff before applying.

GRANT TYPES + AMOUNTS

Project Support:

- Generally, project grants are between \$10,000 to 175,000 over one, two or three years.
- For collaboratives, we will consider requests of up to \$250,000 over one, two or three years. To learn how Meyer defines a collaborative for this purpose, please [click here](#). Please contact a program staff member to determine whether or not your collaborative project is a good fit for a large request and to receive guidance on the amount to request.

In 2016, the average size of a Healthy Environment Statewide Program project grant was \$120,000 over two years.

Capacity Building Support:

- For a broad range of projects designed to strengthen organizational ability and infrastructure, we will consider capacity building requests between \$10,000 to 175,000 over one, two or three years.
- For technical assistance and collaborative planning efforts, grants will be considered in the \$10,000 to \$35,000 range over one year.

In 2016, the average size of a Healthy Environment Statewide Program capacity building grant was \$120,000 over two years. The average size of a technical assistance or collaborative planning grant was \$25,000 over one year.

Operating Support:

- General operating support grants will primarily be awarded to organizations working on public policy and systems change; key intermediaries and networks that serve the interests of many organizations working for a healthy environment; or key organizations or networks that play a unique role in the field and that has wider impact for the sector (e.g. is a field leader in Oregon or nationally). Strong candidate organizations will also demonstrate diversity, equity and inclusion

leadership in the context of the community and field where they work. We strongly encourage you to contact program staff to determine whether your organization is a good candidate for an operating support grant.

- In most cases, operating support grants are \$100,000 or less over two years and are sized in relation to the organization's annual operating budget so that Meyer's grant is roughly no more than 10–20 % of the total budget. We will consider requests of up to \$150,000 over two years for organizations with operating budgets over \$1 million.

In 2016, the average size of a Healthy Environment Statewide Program operating grant was approximately \$90,000 over two years.

Capital Construction Support:

- The Healthy Environment 2017 Annual Funding Opportunity does not support capital projects.

In addition to this funding opportunity, Meyer supports the Conservation Bridge Fund in partnership with Craft3, offering a regional resource for conservation capital that offers short-term, low-interest loans for the following purposes:

- Acquire land and secure conservation easements
- Acquire water rights
- Perform stewardship and restoration activities for projects in Oregon and the Columbia Gorge
- Open spaces
- Working forests
- Working farmlands
- Re-naturing projects in urban areas
- Nature access improvements

- Are committed to equity, diversity and inclusion in their organizations and partnerships
- Have a track record of effective work directly related to our funding priorities or have identified such work as a strategic and mission-aligned priority over the grant period

- Collaborate with other organizations in their community, within the same sector and/ or across sectors
- Recognize the intersection between their organization's work and broader policies and systems
- Have effective leadership that engages a base of community support
- Demonstrate the administrative capacity, financial plan and organizational commitment to implement their proposed project
- Are committed to understanding and evaluating the impact and effectiveness of their work

APPLICATION PROCESS

Meyer uses a two-step application process for our annual funding opportunity.

Applicants should:

- Create or update their profile in GrantIS, Meyer's online application portal. The activation process can take several days, so please be sure to set up your account well in advance of the application deadline.

Meyer will notify organizations in mid-June whether or not they are invited to submit a full proposal. If invited, organizations will have three weeks to do so.

After reviewing proposals and following up either in person or over the phone, we anticipate making final award decisions by the end of 2017, with funding available to organizations in early 2018.

GOAL 1: ACHIEVE THE MUTUAL GOALS OF COMMUNITY WELL-BEING, ECONOMIC VITALITY + ENVIRONMENTAL STEWARDSHIP

Intended Outcomes

- **Innovation + Scaling:** Identification and expanded use of effective models and strategies that provide measurable social, economic and environmental benefits
- **Policy + Systems:** Adoption and implementation of public policies, public investments and institutional practices that provide measurable social, economic and environmental benefits
- **Organizational Capacity:** Strengthened long-term health and capacity of key organizations, collaboratives and networks

Examples of What We Might Fund

We recognize that many organizations identify with this goal and hold sustainability as an organizational value. Please note, however, that projects funded in support of this goal must demonstrate measurable environmental, economic and social impacts. If you will not be able to measure impact in all three of these areas, do not select this goal. Instead, please assess whether your proposed project might be a stronger fit with one of the other goals.

Projects funded under this goal could address a wide range of issues, including (but not limited to) building Oregon’s sustainable food systems, addressing climate justice and clean/renewable energy, improving community livability and the built environment, addressing public health concerns related to the environment or building the restoration economy. We aim to help spark or accelerate efforts aligning with this goal at different scales: a single site, one or more neighborhoods or communities, a city, a region or statewide.

Three examples of what we funded under this goal in 2016 include:

- A collaborative effort to demonstrate a credible approach for implementing community solar projects that serve low-income residents in multi-family affordable housing and create job opportunities for disadvantaged workers and businesses.
- A pilot project with Hacienda CDC, an affordable housing provider in Portland's Cully Neighborhood, that uses a car-sharing program for electric vehicles to reduce air pollution, expand transportation choices and save money.
- A statewide collaborative dedicated to strengthening local and regional food systems that improve economic, social, health and environmental outcomes.

These are only examples to illustrate the types of projects funded under this goal. We invite other ideas that would further our goals and intended outcomes.

GOAL 2: ENSURE THAT ENVIRONMENTAL IMPACTS + BENEFITS ARE EQUITABLY DISTRIBUTED AMONG COMMUNITIES

Intended Outcomes

- **Community Influence:** Increased emphasis on the priorities of communities experiencing disparities in public policy, planning and public investment decisions
- **Increased Opportunities:** Increased opportunities for communities experiencing disparities to benefit from nature and investments in environmental protection
- **Reduced Burdens:** Reduced environmental health burdens on communities experiencing disparities
- **Organizational Capacity:** Strengthened long-term health and capacity of key organizations, collaboratives and networks

Examples of What We Might Fund

Examples of the types of environmental disparities we aim to address include (but are not limited to) the exposure of Oregon’s farm and forestry workers to pesticides and poor living conditions,

disproportionate health burdens impacting Oregon's Native communities as a result of high levels of toxics exposure and inadequate protection of traditional food sources, the disparate impacts of air pollution and industrial pollutants on many of Oregon's most racially diverse communities, and poor access to parks and nature by many low-income communities and communities of color.

Three examples of projects funded under this goal in 2016 include:

- A collaborative effort to develop a new health-based model for clean air management that is informed by communities most affected by air quality impacts
- Adding staff and providing professional development support to reduce exposure of forest workers and harvesters to environmental hazards in the workplace and support forest stewardship best practices.
- Establishing an advocacy coordinator position to organize Portland's low-income communities and communities of color most impacted by environmental hazards to shape public policy on the local and state level

These are only examples to illustrate the types of projects we might fund. We invite other ideas that would further our goals and intended outcomes.

GOAL 3: SUPPORT A MOVEMENT FOR A HEALTHY ENVIRONMENT THAT IS EFFECTIVE + RELEVANT FOR ALL OF OREGON'S DIVERSE COMMUNITIES

Intended Outcomes

- **Equity Focus:** Increased commitment to diversity, equity and inclusion among organizations working for a healthy environment and improved understanding of how to advance equity through their work
- **Collaboration:** Increased collaboration and alignment
- **Capacity:** Strengthened long term health and capacity of key networks and intermediaries
- **Community Influence:** Increased emphasis on the concerns and interests of diverse communities in the public discourse related to a healthy environment

Examples of What We Might Fund

We aim to fund a broad range of projects to further this goal. Examples include (but are not limited to) support for organizational diversity, equity and inclusion training, planning and implementation; collaborations between organizations that serve or are led by communities experiencing disparities, environmental organizations and other nontraditional partners; and support for key intermediaries and coalition builders to advance coordination, effectiveness and impact of the field as a whole.

Three examples of projects funded under this goal in 2016 include:

- Training and staff support to strengthen organizational diversity, equity, inclusion and justice to support climate justice policy efforts.
- Developing a first-ever organizational strategy for diversity, equity and inclusion and provide training to staff and board.
- Delivering a diversity, equity and inclusion training program and peer learning network to a dozen organizations.

These are only examples to illustrate the types of projects we might fund. We invite other ideas that would further our goals and intended outcomes.

GOAL 4: ENSURE THAT NATURAL SYSTEMS ARE HEALTHY AND ABLE TO ADAPT TO CHANGING CONDITIONS + LONG-TERM IMPACTS

Intended Outcomes

- **Ecological Health:** Expanded use of new, promising and proven strategies for protecting or restoring ecosystems and critical natural resources to ensure their long-term health
- **Policy and Systems:** Adoption and implementation of public policies, public investments and institutional practices that support healthy ecosystems and natural resources
- **Organizational Capacity:** Strengthened long-term health and capacity of key organizations, collaboratives and networks

Examples of What We Might Fund

Projects may focus on protecting and restoring the full range of Oregon's ecosystems, including forested mountains, deserts, agricultural valleys, rivers and wetlands, shrub- and grass-covered plains, beaches and nearshore marine ecosystems.

We will prioritize landscape-scale and statewide efforts, including public policy work aimed at establishing new funding and new protection and restoration strategies, as well as efforts that aim to implement existing plans and policies based on sound ecosystem management principles. We expect that funded organizations will demonstrate a commitment to equity, operationalize it in their work and demonstrate progress over time.

Three examples of projects funded under this goal in 2016 include:

- Developing and implementing collaborative water resource management solutions in the Rogue and Umpqua river basins that support ecosystem health while also meeting the cultural and resource needs of tribal communities and ensuring adequate water to sustain the economic foundation of the region's rural communities.
- Establishing an associate director position so that this organization can increase its efforts to develop culturally relevant wetland conservation strategies that serve tribal and rural communities.
- Supporting collaboration by Oregon conservation organizations to shape decisions related to new public funding and policy reforms for water and land conservation.

These are only examples to illustrate the types of projects we might fund. We invite other ideas that would further our goals and intended outcomes.
